ORDINANCE NUMBER O- 16251 (New Series)

AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0504, RELATING TO APPEALS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 5, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 101.0504 to read as follows:

SEC. 101.0504 APPEAL TO BOARD OF ZONING APPEALS FROM DECISION OF ZONING ADMINISTRATOR

- A. and B. No change.
- C. DECISION OF THE BOARD OF ZONING APPEALS
 - 1. and 2. No change.
- 3. The decision of the Board of Zoning Appeals shall be final on the 7th day following action by the Board of Zoning Appeals unless a request to be heard on appeal is filed in the office of the City Clerk in accordance with the procedures provided in paragraph G. of Municipal Code Section 101.0900. For purposes of this subsection, all references to the Planning Commission in Municipal Code Section 101.0900 G. shall be deemed to be references to the Board of Zoning Appeals.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
