AN EMERGENCY INTERIM ZONING ORDINANCE REZONING CERTAIN PROPERTY WITHIN THE CITY OF SAN DIEGO.

WHEREAS, the Council of The City of San Diego has initiated rezoning of certain property within the Uptown Community Plan area of The City of San Diego more particularly described on Drawing No. B-3670, a copy of which is on file in the office of the City Clerk as Document No. 00-16255, from C Zone, Municipal Code Section 101.0432, to R-1 Zone, Municipal Code Section 101.0407; and

WHEREAS, the provisions of Municipal Code Section 101.0205.2 empower and authorize the City Council to enact an ordinance providing that no development inconsistent with the provisions of the zone under consideration shall occur pending determination by the City Council whether or not to enact the rezoning following noticed public hearings; and

WHEREAS, the City Council finds that development inconsistent with the provisions of the R-1 Zone would be detrimental to the public health, safety and general welfare and would frustrate the attainment of General and Community Planning Goals; and

WHEREAS, the City Council finds that development and use of the property in question in a manner inconsistent with the provisions of the R-1 Zone is imminent; NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of San Diego as follows:

Section 1. That the property indicated on Drawing No. B-3670, a copy of which is on file in the office of the CIty Clerk as Document No. 00-16255, shall, from and after the enactment of this ordinance, be governed and regulated by the provisions of the R-1 Zone, Municipal Code Section 101.0407, which zone shall apply to said property for the period provided by this ordinance.

Section 2. This ordinance shall, for the reasons set forth in the preamble hereto, constitute an emergency interim ordinance and shall become effective immediately upon its introduction by the City Council and shall be of no further force and effect 90 days from said date.
