AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 9, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0900, RELATING TO OPEN SPACE IN PLANNED RESIDENTIAL DEVELOPMENTS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 9, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 101.0900, to read as follows:

SEC. 101.0900 PLANNED RESIDENTIAL DEVELOPMENTS

- A. through K. No change.
- L. MINIMUM DEVELOPMENTAL STANDARDS

A Planned Residential Development shall comply with all the following developmental standards:

- 1. No change.
- 2. Open Space. The open space provided on the property shall not be less than that shown in the following table.
