AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 2, DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 62.0405 RELATING TO LAND DEVELOPMENT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 2, Division 4, of the San Diego Municipal Code, be and the same is hereby amended by amending Section 62.0405 to read as follows:

SEC. 62.0405 APPLICATIONS FOR PERMITS

- (a) NO CHANGE.
- (b) NO CHANGE.
- (c) Applications for agriculture permits are required one time only for lands or portions thereof not used for agriculture during the five year period immediately preceding application. A new application shall be required, however, whenever the lands or any portion thereof subject to a previous permit are not used for agriculture during any continuous five year period after the prmit is granted.

Application require a description of the area, statement of crop to be planted, and method of irrigation. Agriculture permits are limited to plowing along the natural surface only or to the making of embankments or excavations within the scope of Section 62.0403 "Exceptions

for Land Development." Environmental clearance is required for endangered species and natural environmental features.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
