AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0414 BY ADDING SUBSECTION "G.," RELATING TO RV ZONE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 4, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 101.0414, to read as follows:

SEC. 101.0414 RV ZONE

A., B., C., D., E. and F. - No changes.

G. COASTAL ZONE REGULATIONS

Within the Coastal Zone, the following regulations shall be supplementary to, and in the event of conflict shall supersede, the regulations set forth or referenced in preceding paragraphs of this Section.

Density Regulations (see also Paragraph
 "D.")

No lot shall be occupied by more than one dwelling unit or two guest rooms for each 1,500 square feet of lot area.

2. Property Development Regulations (see
also Paragraph "E.")

PAGE 1 OF 2

- a. Minimum Lot Dimensions
 - 1) Area 6,000 square feet
- 2) Street Frontage 60 feet, except that for any lot which fronts principally on a turnaround or on a curving street having a radius of curvature of less than 100 feet, the minimum lot frontage shall be 36 feet.
 - 3) Width -
 - (a) Interior Lot 60 feet
 - (b) Corner Lot 65 feet

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0414 BY ADDING SUBSECTION "G," RELATING TO RV ZONE.

This ordinance amends those sections of the San Diego Municipal Code relating to the RV Zone, within the Coastal Zone only, by reducing the meximum allowable density to one unit for every 1,750 square feet of lot area, and by specifying more restrictive minimum tot dimensions than prevail for RV-zoned properties outside the Coastal Zone.
