AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1,
DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 101.0441 BY ADDING SUBSECTION
"E," RELATING TO M-2 ZONE.

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That Chapter X, Article 1, Division 4, of the
San Diego Municipal Code be, and the same is hereby amended by
amending Section 101.0441, to read as follows:

SEC. 101.0441 M-2 ZONE

A., B., C. and D. - No changes.

E. COASTAL ZONE REGULATIONS

Within the Coastal Zone, the following
regulations shall be supplementary to, and in the
event of conflict shall supersede, the regulations set
forth or referenced in preceding paragraphs of this
Section.

1. Off-Street Parking Regulations

a. Every premises used for one or more
of the permitted uses in this zone shall be
provided with a minimum of off-street
parking spaces on the same lot or premises,
except as otherwise provided in Division 8
of this Article, as follows:

(1) For apartments, multiple
dwellings and group dwellings - 1.3

parking spaces for each dwelling unit containing not more than one bedroom, and 1.6 parking spaces for each dwelling unit containing two or more bedrooms.

(2) For hotels and motels - one parking space for each guest room or suite.


(3) For other permitted uses - one parking space for each 1,000 square feet of gross floor area.

b. All off-street parking facilities shall be constructed, operated, and maintained in compliance with Division 8 of this Article.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
