AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1,
DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 101.0506, RELATING TO
CONDITIONAL USE PERMIT GRANTED BY PLANNING
COMMISSION.

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That Chapter X, Article 1, Division 5, of the
San Diego Municipal Code be, and the same is hereby amended by
amending Section 101.0506, to read as follows:

SEC. 101.0506 CONDITIONAL USE PERMIT GRANTED
BY PLANNING COMMISSION

A. USES WHICH MAY BE CONSIDERED

The Planning Commission shall have the authority
under conditions herein provided to permit by
Conditional Use Permit the following uses in any zone,
including interim zones, except as otherwise provided
in Paragraphs "A.1.," "A.2.," "A.5.," "A.6.," "A.12.,"
"A.14.," "A.15.," "A.16.," "A.17." and "A.18." of this
Section:

1. through 17. - No changes.


18. Within the Coastal Zone only, marine-related
uses (including boat building, maintenance, servicing,
repair, and storage; diving, salvage, and underwater
maintenance; marine carpentry and woodworking; sail-
making and repair) in any commercial zone except the

CO and CN zones.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
