AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 2, DIVISION 9 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 62.0903 RELATING TO NEWSRACKS ON PUBLIC RIGHTS-OF-WAY.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter VI, Article 2, Division 9 of the San Diego Municipal Code be and the same is hereby amended by amending Section 62.0903 to read as follows:

SEC. 62.0903 PROHIBITION

No person shall knowingly place or maintain in any newsrack which rests in whole or in part, upon, in, or on any portion of a public right-of-way, or which projects onto, into, or over any part of a public right-of-way, any publication or material which while in said newsrack exposes to public view:

- (a) Any statements or words describing explicit sexual acts, sexual organs, or excrement where such statements or words have as their purpose or effect sexual arousal, gratification, or affront.
- (b) Any picture or illustration of genitals, pubic hair, perineums, anuses, or anal regions of any person where such picture or illustration has as its purpose or effect sexual arousal, gratification, or affront.

(c) Any picture or illustration depicting explicit sexual acts where such picture or illustration has as its purpose or effect sexual arousal, gratification, or affront. Section 2. This ordinance shall take effect and be in force
