follows:


Section 1. That Section 6 of Ordinance No. O-16043 (New
Series), adopted September 12, 1983, be, and the same hereby is
amended to read as follows:

Section 6. The provisions of this ordinance shall be in
force and effect until December 12, 1984, or until the effective
date of the La Jolla Planned District Ordinance, whichever first
occurs.

Section 2. This Ordinance shall take effect and be in force
on the thirtieth day from and after its passage.
