AN ORDINANCE AMENDING ORDINANCE NO. 16249 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16249-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF DEPARTMENT 601 URBAN INFORMATION SYSTEM PROGRAM (60120) IN GENERAL FUND 100, ONE (1) REGIONAL URBAN INFORMATION SYSTEM ADMINISTRATOR POSITION; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, on May 14, 1984, the City Council approved an agreement with the County of San Diego and the San Diego Data Processing Corporation to develop a Regional Urban Information System (RUIS) based on the City's current Urban Information System (UIS); and

WHEREAS, under terms of the agreement, program development will be managed and coordinated by a position entitled "Regional Urban Information System Administrator"; and

WHEREAS, the agreement further provides that the position will be a City employee selected in consultation with the County; and

WHEREAS, the position will have significant latitude in administering and coordinating the development of this functionally and technically complex interjurisdictional system; and

WHEREAS, to implement this recommendation and authorize the additional position, it is necessary to amend the annual appropriation ordinance to provide such position; and

WHEREAS, it is contemplated that the costs for such additional position will be \$7,300 for the fiscal year but those costs can be accommodated by transferring said sum within Department 601, Urban Information System Program (60120) from Supplies and Services to Salaries and Wages; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

1. That Ordinance No. 16249 (New Series), as amended entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16249-1, as adopted and amended therein, by adding to the personnel authorization schedule of Department 601, Urban Information System Program (60120), one (1) Regional Urban Information System position.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100, Department 601, Urban Information System Program (60120), the sum of \$7,300 from Supplies and Services to Salaries and Wages for the purpose of providing funds for the above authorized position.

Section 3. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
