AN ORDINANCE AMENDING ORDINANCE NO. 16249 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16249-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF DEPARTMENT 021, COUNCIL DISTRICT 1, IN GENERAL FUND 100, ONE (1) COUNCIL REPRESENTATIVE I POSITION; EXEMPTING SAID POSITION FROM THE CLASSIFIED SERVICE, AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, Council District 1 has requested the addition of one (1) Council Representative I position to undertake increased workload generated in the district area; and

WHEREAS, said Council District 1 has requested the exemption from the Classified Service of this Council Representative I position which is herein requested to be added to its personnel allocation: and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on September 6, 1984 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, to implement this request and authorize the additional position, it is necessary to amend the annual appropriation ordinance to provide such position; and

WHEREAS, it is contemplated that the costs for such additional position will be \$15,000 for the remainder of fiscal year 1984-85 and those funds can be accommodated by transferring said sum within General Fund 100 from the Unallocated Reserve 605) to Council District 1, Object Account 1100; and

WHEREAS, it is also necessary to amend the annual appropriation ordinance to effectuate said exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 16249 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16249-1, as adopted and amended therein, by adding to the personnel authorization schedule of Department 021, Council District 1, General Fund 100, one (1) Council Representative I position.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100, the sum of \$15,000 from the Unallocated Reserve (605) to Council District 1 (021), for the purpose of providing funds for the above authorized position.

Section 3. That pursuant to section 117(a)17 of the City Charter, the Civil Service Commission has reviewed on September 6, 1984, and commented favorably upon the request for exemption of said position from the Classified Service.

Section 4. As a schedule of compensation for the above unclassified position, the salary rate set forth in Salary Rate 7.0 and 7.1 of the Table of Classifications and Standard Salary Rates under Managerial Category A, contained in Exhibit C to Ordinance No. 16214 (New Series), dated May 29, 1984, be and the same is hereby adopted.

Section 5. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
