AN ORDINANCE INCORPORATING A PORTION OF SECTIONS 1, 2 AND 35, TOWNSHIP 19 SOUTH, RANGE 2 WEST, S.B.B.M.; LOTS 117-118, 120-121, 158-163, A-(37-40), A-(45-50), A-(52-54), A-(203-204); AND PORTION OF LOT N, SAN YSIDRO MAP NO. 1174, (APPROXIMATELY 30.4 ACRES), IN THE SAN YSIDRO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CR AND CA-RR ZONES, AS DEFINED BY SECTIONS 101.0421.1 AND 101.0427.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8028 (NEW SERIES), ADOPTED DECEMBER 18, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That a portion of Sections 1, 2 and 35, Township 19 South, Range 2 West, S.B.B.M.; Lots 117-118, 120-121, 158-163, A-(37-40), A-(45-50), A-(52-54), A-203-204); and portion of Lot N, San Ysidro Map No. 1174, (approximately 30.4 acres), in the San Ysidro Community Plan area, located north and south of I-5, near Cottonwood Road and Smythe Avenue, to the north and Calle Primera to the south, in the City of San Diego, California, within the boundary of the district designated "CR" and "CA-RR" on Zone Map Drawing No. B-3653.1, filed in the office of the City Clerk as Document No. 768982, be, and it is hereby incorporated into CR and CA-RR Zones, as such zones are described and defined by Sections 101.0421.1 and 101.0427.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8028 (New Series), adopted December 18, 1958, of the ordinances of The City of San Diego

be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
