ADOPTED ON OCT 1 1984

AN ORDINANCE AMENDING ORDINANCE NO. O-16249 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16249-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING SECTION 2.II. THEREOF TO ADD A NEW SUBSECTION 34 ENTITLED "DELLS AND MOUNT HOPE PROJECT FUND (10232)" TO PROVIDE FUNDS FOR FUTURE USE IN SAID PROJECTS.

WHEREAS, the Redevelopment Agency has discussed and considered the desirability of establishment of a fund to accommodate the Dells and Mount Hope Projects; and

WHEREAS, said Agency approved that concept and now requests the City Council to amend the Annual Appropriation Ordinance to meet the need; and

WHEREAS, after consideration of the matter, the City Council has determined that the express establishment of a fund in the Annual Appropriation Ordinance is necessary and desirable for the purposes stated in the amendatory language; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

1. That Ordinance No. O-16249 (New Series), as amended entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is

hereby further amended by amending Document No. 00-16249-1, as adopted and amended therein, by amending Section 2.II. thereof to add a new subsection 34, entitled "DELLS AND MOUNT HOPE PROJECT FUND (10232)," to read as follows:

34. DELLS AND MOUNT HOPE PROJECT FUND (10232)


The Dells and Mount Hope Project Fund is hereby established to provide for the deposit of CDBG Program Income consisting of disposition proceeds and other revenues, exclusive of tax increment, generated from the Dells and Mount Hope Projects.

Any monies deposited in the Dells and Mount Hope Project Fund are hereby appropriated for transfer to the Redevelopment Agency to be utilized in the future phases of the Dells and Mount Hope Projects as directed by the Redevelopment Agency.

Section 2. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
