AN ORDINANCE SETTING ASIDE A PORTION OF HILLTOP PARK AND RECREATION CENTER FOR PUBLIC STREET PURPOSES.

WHEREAS, The City of San Diego is the owner of 33.2 acres of land in the Penasquitos area which is dedicated parkland and identified as Hilltop Park and Recreation Center; and

WHEREAS, the City Manager has recommended that a portion of said Hilltop Park be set aside and dedicated for a public street; and

WHEREAS, the City Manager recommends, and the City Council hereby finds, that the public interest demands the dedication of the street as herein described; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, that a portion of Section 7, Township 14 South, Range 2 West, being a dedicated park commonly known as Hilltop Park and Recreation Center, which portion is more particularly described in Engineer's Drawing No. 21426-1-D, a copy of which is on file in the office of the City Clerk as Document No. 00- 16298, be and the same is hereby set aside and dedicated as and for a public street, and the same is hereby named OVIEDO WAY.

BE IT FURTHER ORDAINED, that the City Clerk is directed to forward a copy of this ordinance, attested by him under seal, to the Property Department for further handling.
