AN ORDINANCE INCORPORATING LOTS 7 AND 8, BLOCK 2 OF OCEAN SPRAY ADDITION, MAP NO. 941 (A 4,214 SQUARE-FOOT SITE), LOCATED AT 5016 MISSION BOULEVARD, IN THE MISSION-PACIFIC BEACH COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1500 ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 2593 (NEW SERIES), ADOPTED DECEMBER 29, 1942, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

Section 2. That Ordinance No. 2593 (New Series), adopted December 29, 1942, of the ordinances of The City of San Diego be and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
