AN ORDINANCE AMENDING ORDINANCE NO. 0-16249 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16249-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE FINANCIAL MANAGEMENT DEPARTMENT (055), ONE (1) ASSOCIATE ADMINISTRATIVE ANALYST POSITION; TRANSFERRING THE SUM OF \$27,179 WITHIN THE GENERAL FUND 100, FROM UNALLOCATED RESERVE (605) TO THE FINANCIAL MANAGEMENT DEPARTMENT (055) FOR THE PURPOSE OF FULLY FUNDING THE ABOVE AUTHORIZED POSITION FOR THE REMAINDER OF FISCAL YEAR 1985.

WHEREAS, on October 8, 1984, the Rules Committee considered the matter of various alternatives regarding the level of review for agency budgets as well as the publication of agency budgets in the annual budget volume; and

WHEREAS, such Committee consideration encompassed review and discussion of City Manager Reports No. 84-356 and 84-404; and

WHEREAS, the Committee directed the City Manager to provide for full review and analysis of agency budgets and authorized an additional Associate Administrative Analyst position for such function, as recommended in City Manager Report No. 84-356; and

WHEREAS, said position is to be hired during fiscal year 1985, to be funded from the Unallocated Reserve and in succeeding years, to be regularly budgeted; and

WHEREAS, it is necessary to amend the annual appropriation ordinance to effectuate such addition to the Financial Management Budget; and


WHEREAS, the Rules Committee now forwards the matter to the full Council with a recommendation to approve such action; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-16249 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16249-1, as amended and adopted therein, by adding to the personnel authorization schedule of the Financial Management Department (055), 1.00 Associate Administrative Analyst position.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100, the sum of \$27,179 from the Unallocated Reserve (605) to the Financial Management Department (055) for the purpose of fully funding the above authorized position for the remainder of fiscal year 1985.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings,



pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
