AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE, BY ADDING SECTION 101.0245, RELATING TO RECORDATION OF VARIANCES, PERMITS OR ENTITLEMENTS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 2, of the San Diego Municipal Code be, and the same is hereby amended by adding Section 101.0245 to read as follows:

SEC. 101.0245 RECORDATION OF VARIANCES, PERMITS OR ENTITLEMENTS

Upon approval of a variance or any of the permits or entitlements listed in this section, all of which are found to constitute instruments affecting title to or possession of real property, the variance, permit or entitlement shall be recorded in the office of the County Recorder of San Diego County.

- C. Section 101.0452.1, Height Limit Exception La Jolla.
