AN ORDINANCE AMENDING ORDINANCE NO. 0-16249 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16249-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE FIRE DEPARTMENT (DEPT. 12000), FIRE PREVENTION BUREAU (12030), ONE (1) FIRE CAPTAIN AND TWO (2) FIRE ENGINEER POSITIONS; TRANSFERRING THE SUM OF \$114,000 WITHIN THE GENERAL FUND 100 FROM UNALLOCATED RESERVE (605) TO FIRE DEPARTMENT/FIRE PREVENTION BUREAU (12030) FOR THE PURPOSE OF PROVIDING PERSONNEL AND RELATED NON-PERSONNEL FUNDS FOR THE ABOVE POSITIONS.

WHEREAS, as a budget reduction measure, the Fire Department eliminated three positions in the Fire Prevention Bureau in this fiscal year's budget; and

WHEREAS, these positions, one Fire Captain and two Fire Engineers acting as Fire Company Inspection Advisors, are currently used to train and assist fire companies in conducting more complex fire prevention inspections; and

WHEREAS, it was the Department's intent to transfer that responsibility to existing fire company personnel with previous fire prevention experience; and

WHEREAS, during Budget Review, the City Council approved the budget with the reduction but directed the City Manager to delay implementing the new approach until the Department had met and conferred with Local 145 and pursuant to that direction, the Department retained the three Advisor positions over budget; and

WHEREAS, it was agreed that shifting inspection advisor responsibility to suppression personnel should not be implemented and that the three Advisors' positions currently being carried over budget should be reinstated to the budget; and

WHEREAS, as a result of the above, it is now necessary and desirable to amend the Annual Appropriation Ordinance to effectuate said action; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16249 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984-85 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16249-1, as amended and adopted therein, by adding to the personnel authorization schedule of the Fire Department (12000), Fire Prevention Bureau (12030), 1.00 Fire Captain and 2.00 Fire Engineer positions.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100, the sum of \$114,000 from the Unallocated Reserve (605) to Fire Department, Fire Prevention Bureau (10230), for the purpose of providing personnel and related non-personnel funds for the above authorized positions.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings,

pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
