AN ORDINANCE INCORPORATING LOT 1, DAVEY SUBDIVISION, MAP NO. 6135; LOTS 25 THROUGH 28, INCLUSIVE, BLOCK 1, ORANGE PARK, MAP NO. 1210; LOTS 2 THROUGH 13, INCLUSIVE, BLOCK 6, HAFFENDEN'S SUNNYDALE, MAP NO. 419; LOTS 25 THROUGH 48, INCLUSIVE, BLOCK 1 AND LOTS 4 THROUGH 14, INCLUSIVE, BLOCK 2 OF BRODERICK AND WEST ADDITION, MAP NO. 1117, (APPROXIMATELY 2.84 ACRES), IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B ZONE, AS DEFINED BY SECTION 101.0435.2 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12795, ADOPTED APRIL 14, 1930; ORDINANCE NO. 6990 (NEW SERIES), ADOPTED MARCH 22, 1956 AND ORDINANCE NO. 9585 (NEW SERIES), ADOPTED FEBRUARY 16, 1967, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance Lot 1, Davey Subdivision, Map No. 6135; Lots 25 through 28, inclusive, Block 1, Orange Park, Map No. 1210; Lots 2 through 13, inclusive, Block 6, Haffenden's Sunnydale, Map No. 419; Lots 25 through 48, inclusive, Block 1 and Lots 4 through 14, inclusive, Block 2 of Broderick and West Addition, Map No. 1117, (appoximately 2.84 acres), in the Southeast San Diego Community Plan area, in The City of San Diego, California, designated "M-1B" on Zone Map Drawing No. B-3681, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or

subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0435.2 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into M-1B Zone, as described and defined by Section 101.0435.2, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3681, filed in the office of the City Clerk as Document No. 769058. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinances No. 12795, adopted April 13, 1930, 6900 (New Series), adopted March 22, 1956, and 9585 (New Series), adopted February 16, 1967, be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
