
AN ORDINANCE AUTHORIZING THE LEASING OF FIRE APPARATUS FOR A TERM EXTENDING BEYOND FIVE YEARS.

BE IT ORDAINED by the Council of the City of San Diego, that the bid of FISCAL FUNDING, CO., INC., is accepted and that the City Manager be and he is authorized and empowered to execute a Lease Option Agreement for the leasing of fire apparatus described in Exhibit "A" of the Lease Option Agreement, a copy of which is on file in the Office of the City Clerk, as Document No. 00- 16337 for the period of sixty (60) months from the date of the acceptance of delivery of each piece of equipment, for an annual rental of \$502,246.80, as set forth in Exhibit "B" of the Lease Option Agreement and according to the terms thereof; and to take all further actions necessary to thereafter carry out the terms of the Lease Option Agreement.

BE IT FURTHER ORDAINED that this ordinance shall take effect on and after the thirtieth (30th) day from the date of its passage.
