AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 35 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 33.3513 RELATING TO HOURS OF OPERATION OF MASSAGE ESTABLISHMENTS.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter III, Article 3, Division 35 of the San Diego Municipal Code be and the same is hereby amended by amending Section 33.3513 to read as follows:

SEC. 33.3513 MASSAGE ESTABLISHMENTS - OPERATING REQUIREMENTS

(a) thru (b) No change.

(c) No massage operation shall be carried on and no massage establishment premises shall be open between the hours of 10:30 p.m. and 7:00 a.m. All customers, patrons and visitors shall be excluded from such premises during those hours.

(d) thru (t) No change.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
