That the bids of 1. MISSION FORD TRACTORS, INC. and 2. CASE POWER & EQUIPMENT are hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of VARIOUS TRACTORS as follows:

- 1. MISSION FORD TRACTORS, INC. for Item 1, two (2) each medium tractors with front loaders at a cost of \$21,950.00 each; Item 2, one (1) each medium tractor with loader and backhoe (55 H.P.) at a cost of \$27,600.00; Item 4, one (1) each medium tractor with loader and backhoe (45 H.P.) at a cost of \$23,675.00; and Item 5, two (2) each medium tractors with loader and extendable backhoe at a cost of \$31,020.00 each; for a total cost of \$157,215.00; terms net 30 days, plus sales tax.
- 2. CASE POWER & EQUIPMENT for Item 3, one (1) each medium tractor with four wheel drive and front loader (14,700 lbs.) at a cost of \$43,800.00, and Item 6, one (1) each medium tractor with four wheel drive and front loader (15,000 lbs.) at a cost of \$39,940.00, for a total cost of \$83,740.00; terms net 30 days, plus sales tax.
