BE IT FURTHER RESOLVED, that the Purchasing Agent is hereby authorized to advertise for bids for the RENOVATION OF SAN DIEGO JACK MURPHY STADIUM PLAYING FIELD-1984.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add CIP 34-103.0, Renovation of San Diego Jack Murphy Stadium Playing Field-1984, to the FY-1984 Capital Improvement Program.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$365,000 from the Stadium Operations Fund 10330 (CIP 34-103.0), for the purpose of executing a contract and related costs, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder.
