BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

REPLACEMENT OF THE 32ND STREET BRIDGE CROSSING LAS CHOLLAS CREEK.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$80,000.00 from Capital Outlay Fund 30245, CIP No. 90-245 Capital Outlay Reserve to CIP No. 53-033 32ND STREET BRIDGE OVER CHOLLAS CREEK.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,042,400.00 from Capital Outlay Fund 30245, CIP No. 53-033 32ND STREET BRIDGE OVER CHOLLAS CREEK is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
