

RESOLUTION NUMBER R- **259881**

Adopted on JAN 3 1984

WHEREAS, The City of San Diego (herein called "City") and Medevac, Inc. (herein called "Medevac") are parties to an agreement dated July 1, 1978, as amended (herein called "Agreement"), for paramedic services; and

WHEREAS, Section 6.a.(3) provides for the submission of a Revised Budget based upon any change in condition or circumstances which may have occurred during any fiscal year; and

WHEREAS, changes in Medicare regulations no longer allow the billing of supplies used by paramedic ambulances through a hospital emergency room bill; and

WHEREAS, the City, through Medevac, is incurring significant costs due to this change in procedure; and

WHEREAS, the City Council adopted Resolution R-255829 on February 16, 1982 authorizing the City Manager to implement itemized Paramedic Program user fees according to a Schedule of Proposed Paramedic User Rates; and

WHEREAS, City and Medevac wish to revise Medevac's current fiscal year budget without an increase in the overall cost and amend said Schedule of Proposed Paramedic User Rates to provide for the changes in Medicare regulations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Medevac's current budget is hereby revised without an

increase in the overall cost to provide for the reimbursement by City to Medevac of the costs incurred by Medevac for reimbursement of medical supplies, drugs and related items used in conjunction with the provision of paramedic services, and the City Manager is authorized to amend the Schedule of Proposed Paramedic User Rates adopted on February 16, 1982, as necessary, to provide for the recovery of an amount not to exceed the costs to the City for medical supplies, drugs and related items used in conjunction with the provision of paramedic services from those individuals who use said paramedic services.
