BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder, subject to the successful sale of Certificates of Participation, for CONSTRUCTION OF SOUTHEASTERN DIVISION POLICE STATION.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$2,424,000.00 from Certificates of Participation proceeds is hereby authorized solely and exclusively for providing funds for

said project and related costs, subject to the successful sale of Certificates of Participation, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
