Jan E. Johnson	City Clerk	\$ 235	Ms. Johnson is an Intermediate Typist. She suggested the purchase of a labeling machine to expedite mailings, omit travel time and contractual costs. Her suggestion is expected to save \$1,552 in the first year. This is a partial award pending a final 12-month review.
Donald J. Makie, Jr.	Park & Recreation	\$ 100	Mr. Makie is an Area Manager in the Eastern Division. He suggested that Security Awareness training be provided all employees handling City monies. Although the savings are difficult to calculate, this was considered to be a significant work quality and safety improvement.
Kim C. When	Fire	\$ 100	Mr. When is a Fire fighter. He suggested the use of language cards to communicate with foreigners in emergency situations. Although savings are difficult to calculate, this suggestion was considered to be a significant operational improvement in the areas of public safety and communications.
