

RESOLUTION No. R-259913 (R-84-1133)

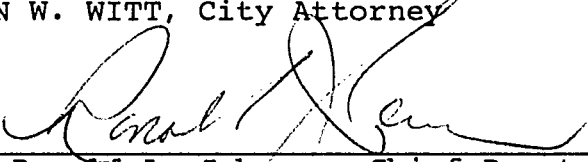
Adopted on JAN 3 1984
