

RESOLUTION No. R- 259916 (R- 84-1025)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. ROBINSON FERTILIZER COMPANY, 2. BUTLER'S MILL, INC., 3. LOS ANGELES CHEMICAL COMPANY, and 4. SOUTHERN CALIF. ORGANIC FERTILIZER CO. INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of FERTILIZERS, PESTICIDES, AND HERBICIDES, ETC. as may be required for a one (1) year period beginning January 1, 1984 through December 31, 1984, per prices on file in the Purchasing Department, as follows:

1. ROBINSON FERTILIZER COMPANY for Items 1, 2, 5, 29, 30, 38, 41 and 46; terms net 30 days, plus sales tax, with a potential escalation not to exceed 10% during the contract period, and with an option to renew contract for an additional one (1) year period with potential escalation not to exceed 10% during the option period.
2. BUTLER'S MILL, INC. for Items 3, 4, 6, 7, 8, 9, 10, 12, 13, 14, 15, 16, 17, 19, 20, 21, 22, 23, 24, 25, 26, 31, 32, 33, 35, 36, 37, 39, 42, 44, 47, 48, 49, 50 and 51; terms net, plus sales tax, with an option to renew contract for an additional one (1) year period with escalation not to exceed 12% during the option period.
3. LOS ANGELES CHEMICAL COMPANY for Items 11, 34 and 43; terms net 30 days, plus sales tax, with a potential escalation not to exceed 15% during the contract period.
4. SOUTHERN CALIF. ORGANIC FERTILIZER CO. INC. for Items 27 and 28; terms net, plus sales tax.
