RESOLUTION NUMBER R- 259922

WHEREAS, Section 8330, et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets and public easements by City Council resolution where a portion of street or highway lies within property under one ownership and that does not continue through such ownership or end touching property of another; and

WHEREAS, in connection with said vacation, the City desires to reserve a certain easement; and

WHEREAS, the abutting property owners have requested the vacation of Poway Avenue and portions of Chase and Truckee Avenues between Mission Center Road and Interstate Highway 805, and the Alley in Block 4 of Cable Road Addition, Map 669, all within or adjacent to the boundaries of the final Nob Hill Subdivision map, to facilitate development of their property; and

WHEREAS, the streets and alley to be vacated are not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the streets to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as

follows:

- 1. That Poway Avenue and portions of Chase and Truckee Avenues between Mission Center Road and Interstate Highway 805, and the alley in Block 4 of Cable Road Addition, Map 669, all within or adjacent to the boundaries of the final Nob Hill Subdivision Map (TM 82-0732), as more particularly shown on Drawing No. 21066-D, on file in the office of the City Clerk as Document No. RR-2599227, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- That The City of San Diego hereby reserves and excepts the right, easement, and privilege of placing, constructing, repairing, replacing, maintaining, using, and operating public utilities of any kind or nature, including, but not limited to, water utilities and all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along, and across the hereinafter-described easements, together with the right of ingress thereto and egress therefrom, together with the right to maintain the said easement free and clear of any excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon acquisition of encroachment permit from the City Engineer pursuant to the Municipal Code of the City, the owners of the underlying fee may utilize the above-described parcel of land for structures, the planting or growing of trees, or the

installation of privately owned pipelines.

- 3. That the easement reserved herein is in, under, over, upon, along, and across Truckee Avenue adjacent to Parcel A of Parcel Map 711, Poway Avenue adjacent to Parcel A of Parcel Map 749, and the Alley adjacent to Lots 29-31, in Block 4 of Cable Road Addition, Map 669, vacated by this document, and as more particularly shown on Drawing 21066-D, on file in the office of the City Clerk as Document No. 259922
- 4. That this resolution shall not become effective unless and until the Nob Hill Subdivision map (TM 82-0732) has been approved by Council action. In the event that the final map is not approved by February 22, 1985, this resolution shall become void and be of no further force or effect.
- 5. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
