

RESOLUTION No. R-259947 (R- 84-1155)


Adopted on JAN 10 1984

BE IT FURTHER RESOLVED that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$105,074.83 made payable to Luth and Turley, Inc. in full settlement of all claims. An advance of \$18,768.56 has been previously paid to the firm of Luth and Turley.
