BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of UNIVERSITY FORD is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of EIGHTEEN (18) POLICE SEDANS; eight (8) police sedans with vinyl interiors (1984 Ford LTD with 232 CID 6 cylinder engine) at a cost of \$9,007.77 each and ten (10) police sedans with cloth interiors (1984 Ford LTD with 232 CID 6 cylinder engine) at a cost of \$9,049.79 each for a combined total of \$162,560.06; terms net 30 days, plus sales tax, less trade-in allowance as follows:
