WHEREAS, the City desires to exercise its option to extend the contract for the period starting December 1, 1983, through June 30, 1984.

NOW, THEREFORE, BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an amendment to the Agreement with AUTO-GRAPHICS, INC., to extend the Agreement under the terms, conditions, and prices on file in the Purchasing Department.
