APPROVING MAP OF
EASTGATE TECHNOLOGY PARK UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Stuart Peace, a registered civil engineer, entitled "EASTGATE TECHNOLOGY PARK UNIT NO. 1, being a subdivision of portions of Pueblo Lots 1316, 1317, 1318 and 1351 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in the year 1870, a copy of which said map being filed in the office of the County Recorder of San Diego County and is known as Miscellaneous Map No. 36, together with Eastgate Mall as dedicated to public use, and together with Miramar Road and portions of Eastgate Mall as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Town Centre Drive, and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication that portion of Lot 4 marked "Reserved for Future Street," as shown on this map, under the provisions of Section 66440 of the Government Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated and that said Council has rejected a portion of Lot 4 marked "Reserved for Future Street."

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
