WYLIE CONSTRUCTION CO., said contract having been filed in the office of the City Clerk as Document No. A00149, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$35,496.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$35,496, from Sewer Revenue Fund 41506, CIP No. 46-071, Sewer Grant Project 540, is hereby authorized, solely and exclusively for the purpose of funding this change order.
