WHEREAS, said section was amended by Ordinance No. O-16088 on December 5, 1983 to increase the membership thereof from seven (7) to nine (9) members; and


WHEREAS, it is now necessary and appropriate to make those additional appointments in addition to making regular appointments for expired terms; NOW, THEREFORE,
