WHEREAS, The City of San Diego adopted Resolution No. R-259549 on November 1, 1983, expressing and declaring its opposition to the construction of the proposed bullet train project; and


WHEREAS, various cities similiarly impacted by the train project are joining together to file a declaratory relief lawsuit opposing the continuance of the bullet train project legislative consideration and planning; and

WHEREAS, it is deemed necessary and desirable for The City of San Diego to join in said declaratory relief lawsuit with the cities of Tustin, Oceanside, Carlsbad and Del Mar; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and behalf of the people of San Diego, does hereby express its desire and approval for the City to join the cities of Tustin, Oceanside, Carlsbad and Del Mar in the declaratory relief legal action concerning the bullet train project.

BE IT FURTHER RESOLVED, that the City Attorney be and he is hereby authorized to take all action necessary to effect said joinder in the the above specified declaratory relief action.
