2. That the Auditor and Comptroller be and he is hereby authorized to consolidate \$100,000 from CIP 62-212.0, Euclid Avenue and Logan Avenue/Olvera Avenue into CIP 62-229.0, Camino De La Plaza, East Beyer Boulevard and San Ysidro Boulevard.
