

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with HERMAN KIMMEL AND ASSOCIATES, INC. for professional engineering services in connection with the design of Camino De La Plaza/East Beyer Boulevard and San Ysidro Boulevard, and Euclid Avenue and Logan Avenue/Olvera Avenue, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-25993
- 2. That the Auditor and Comptroller be and he is hereby authorized to consolidate \$100,000 from CIP 62-212.0, Euclid Avenue and Logan Avenue/Olvera Avenue into CIP 62-229.0, Camino De La Plaza, East Beyer Boulevard and San Ysidro Boulevard.



3. That the expenditure of \$12,150 from CIP-229.0, Camino De La Plaza, East Beyer Boulevard and San Ysidro Boulevard and, Euclid Avenue and Logan Avenue/Olvera Avenue, Gas Tax Fund for the purpose of executing this agreement is hereby authorized.
