BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a First Amendment to Lease Agreement with HORSEMAN'S PARK, INC. to provide for certain reductions in rent during rainy periods, under the terms and conditions set forth in that First Amendment to Lease Agreement on file in the office of the City Clerk as Document No. RR- 259998.

BE IT FURTHER RESOLVED, that unpaid rents in the amount of \$9,023 for the period November 1982 to April 1983 are hereby waived in view of substantial flooding which existed during said period and which reduced the availability of the leasehold for use by the public.
