WHEREAS, on September 27, 1983, the Housing Advisory and Appeals Board at a public hearing approved said findings. NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the residential premises described above is declared to be a public nuisance.
