James A. Toci	General Services	\$ 4,185	Mr. Toci is an Assistant Electrical Engineer in the General Services Department, Communications and Electrical Division. He suggested that the small incandescent quartz lights be eliminated on City-owned tennis courts. This suggestion has saved the City \$13,943.68 in the first year.
Geraldine Bollenbach	Water Utilities	\$ 1,755	Ms. Bollenbach is a Drafting Aide in the Water Utilities Department, Maps and Records Division. She suggested the elimination of Saturday reservoir checks at Chollas. This is expected to save \$11,562.72 in the first year in time.
Elizabeth Webb	Library	\$ 790	Ms. Webb is a Senior Librarian. She suggested that the limit for writing receipts for library fines be changed from \$5.00 to \$10.00. This suggestion is expected to save \$2,633 in time and material.
