Jacqueline Clayton	General Services	\$ 200	Ms. Clayton was an Auto Messenger in the General Services Department at the time she suggested that bulletin boards with pertinent information be positioned above the mail cases to expedite the mail system. Her suggestion is expected to save \$644.30 in the first year in costs for time.
Barbara Center-Amy	Personnel	\$ 185	Ms. Center-Amy is a Senior Clerk in the Personnel Department. One year ago she earned a partial award of \$220 for her suggestion to mail postcard notices to candidates for notification of list extensions. One year's experience has shown a savings of \$1,348.17. This is the remainder of her award.
Jacqueline Clayton	General Services	\$ 115	Ms. Clayton was an Auto Messenger in the General Services Department at the time she suggested the construction of a rack to hang mail sacks to expedite the mail system. Her suggestion is expected to save \$383.82 in the first year in costs for time.
