

RESOLUTION NUMBER R- 260023

APPROVING MAP OF SUNRISE ADDITION UNIT NO. 3

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Dennis J. Sloan, a registered civil engineer, entitled "SUNRISE ADDITION UNIT NO. 3, being a subdivision of a portion of the southeast quarter of the northeast quarter and a portion of the northeast quarter of the southeast quarter of Section 33, Township 18 South, Range 2 West, San Bernardino Meridian, according to United States Government Survey approved February 25, 1870, and Parcel No. 1, according to Parcel Map No. 4182, in the City of San Diego, County of San Diego, State of California, together with a portion of Hollister Street as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Rodear Road, Risueno Court, Simpatico Court, Atherton Avenue, Honestidad Road, Madreselva Way and a portion of Hollister Street, and said streets and portion of street are hereby declared to be public streets and a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Hollister Street, adjacent and contiguous to Lots 1 through 14, inclusive, and Lot 75, and in and to Tocayo Avenue, adjacent and contiguous to Lots 14, 15, 29, 30, 31, 41, 42 and 47 through 51, inclusive, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of a public street are accepted on behalf of the public as heretofore stated and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
