RESOLUTION NUMBER R- 260026

Adopted on JAN 30 1984

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where for a period of five consecutive years the street to be vacated has been impassible for vehicular travel and during such period no public money has been expended for maintenance; and

WHEREAS, the property owners have requested the vacation of Marilou Road (RS 90) west of 47th Street in Lots 13 and 18 of Horton's Purchase, Map 283, all within the boundaries of the proposed Coca Cola Bottling Company Subdivision (TM 83-0101), to facilitate development of their properties; and

WHEREAS, the street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Marilou Road (RS 90) west of 47th Street in Lots 13 and 18 of Horton's Purchases, Map 283, all within the boundaries of the proposed Coca Cola Bottling Company Subdivision (TM 83-

0101), as more particularly shown on Drawing No. 15792-B, on file in the office of the City Clerk as Document No. RR-260026-1., which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the resolution shall not become effective unless and until the final subdivision map for the Coca Cola Bottling Company Subdivision (TM 83-0101) has been approved by Council action. In the event that the final map is not approved by February 1, 1984, this resolution shall become void and be of no further force or effect.

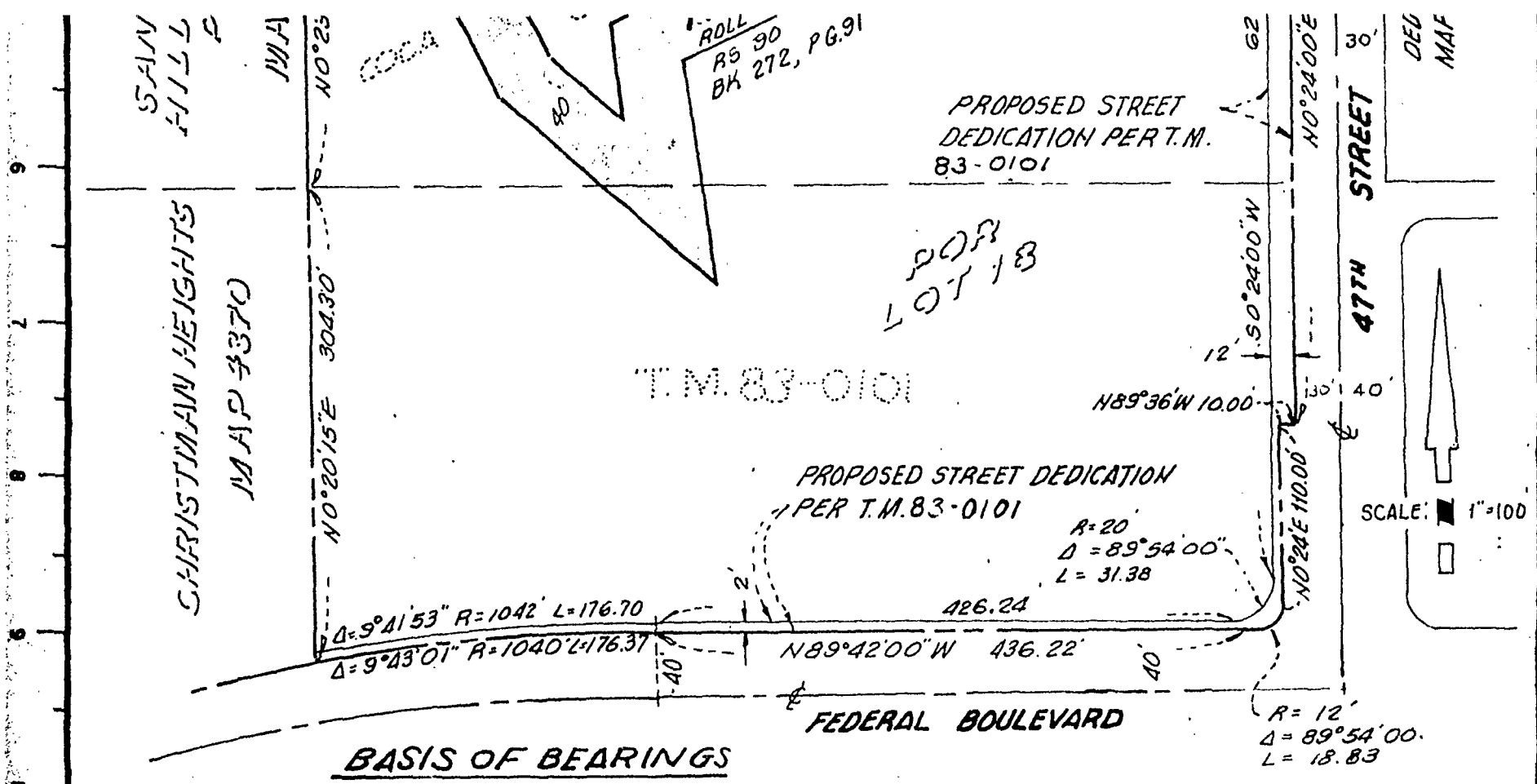
3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
