WHEREAS, LIFE INSURANCE COMPANY OF CALIFORNIA has requested an exchange of sewer and water easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement which was acquired by Resolution No. RR-258054 on March 7, 1983, will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 260027 - 1 , quitclaiming to LIFE INSURANCE COMPANY OF CALIFORNIA, all of the City's right, title and interest in the sewer and water easements in Lot 14 of Torrey Pines Science Park Unit 3, Map No. 9230, as more particularly described in said deed.

2. That the City Clerk is hereby authorized and directed to deliver the quitclaim deed, and a certified copy of this resolution, attested by him under seal, to the Engineering and Development Department for further handling.
