RESOLUTION NUMBER R- 260028

WHEREAS, the vacation of the City's interest in an unneeded sewer easement affecting Lot 9, Block 108 of Middletown, as more particularly shown on Drawing No. 15454-B, on file in the office of the City Clerk as Document No. RR- 260028-2, has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easement has never been used, and is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 8300 et seq. of the Streets and Highways Code the sewer easement, as more particularly shown on Drawing No. 15454-B is hereby vacated.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No.

RR- 260028-1 , quitclaiming to COLUMBIA TERRACE LIMITED, a California limited partnership, that certain easement as more particularly described in said quitclaim deed.

3. That the City Clerk of said City be, and he is hereby authorized and directed to cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
