WHEREAS, Alvarado Creek overflowed on or about February 20, 1980, causing the flooding of the Mission Office Park and business premises in an amount alleged to be in the area of \$1.75 million; and

WHEREAS, litigation against The City of San Diego has been instituted by tenants so affected, with 17 separate cases having been consolidated for trial; and

WHEREAS, the litigation is and will be protracted and involves complex factual and legal issues; and

WHEREAS, the City Attorney has recommended that private legal counsel be retained to defend the City in this case in order to provide sufficient legal expertise on the City's behalf and provide the attention and effort deemed necessary for proper defense; and

WHEREAS, in Closed Session on January 10, 1984, the City Council unanimously approved said recommendation to retain outside counsel for the defense of the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of twenty thousand dollars (\$20,000) within Fund 100 from the Unallocated Reserve (605) to the Allocated Reserve (901) for the sole and exclusive purpose of providing funds for the payment of attorney's fees to private

legal counsel, as billed, for services rendered in the defense of the case Ektelon v. City of San Diego, et al., and consolidated cases, Superior Court No. 464215.
