

RESOLUTION NUMBER R- 260035

Adopted on JAN 30 1984

WHEREAS, the Mayor of The City of San Diego proposed in his State of the City address on January 9, 1984 that a Growth Managment Review Task Force be formed; and

WHEREAS, the Task Force would undertake its assigned tasks and provide a final report thereon to the Council by October 1, 1984; and

WHEREAS, the Task Force's tasks are set forth in the January 19, 1984 memorandum from the Mayor to the Rules Committee; and

WHEREAS, the Mayor will be coming forward, pursuant to Charter section 43(b), with his appointments to this ad hoc Task Force for Council information; and

WHEREAS, the Rules Committee reviewed the information provided in respect to the ad hoc Task Force and, after full discussion and deliberation, approved said action unanimously and recommends that the full City Council similarly approve said action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the proposal by the Mayor of The City of San Diego for establishment of a Growth Management Review Task Force, pursuant to the provisions of Charter section 43(b), be and the same is hereby adopted.

BE IT FURTHER RESOLVED, that the statement of tasks to be assigned to and undertaken by the Task Force that are set forth


in the January 19, 1984 memorandum from the Mayor to the Rules Committee, which were approved unanimously by said Committee, be and the same are by this reference, fully incorporated herein, and are hereby approved and adopted.

BE IT FURTHER RESOLVED, that the City Manager and Planning Director be and they are hereby directed to identify the staffing requirements from existing budgets to support said Task Force.

BE IT FURTHER RESOLVED, that the Task Force be and it is hereby directed to submit its final report and recommendations to Council in respect to the tasks assigned by October 1, 1984.
