RESOLUTION NUMBER R- 260037

Adopted on JAN 30 1984

WHEREAS, on January 25, 1984, the Public Services and Safety Committee (herein "Committee") discussed funding of various projects because of a referral from the full City Council; and

WHEREAS, the subject of providing the sum of \$310,000 in matching funds for a SEDC-UDAG grant match for construction of hotel facilities and amenities on the site of the Ebony Motel in Southeast San Diego was included therein; and

WHEREAS, the Committee discussed and unanimously approved the allocation of revenue sharing funds for this purpose; and

WHEREAS, it is necessary to conduct a noticed hearing pursuant to appropriate federal statutes, for the allocation and expenditure of federal revenue sharing funds; and

WHEREAS, such public noticed hearing on the item will be conducted and, if approved, it will then be necessary to amend the annual appropriation ordinance to reflect said allocation of revenue sharing funds for said purpose; and


WHEREAS, it is the intent of the Council to so allocate said funds and to declare such intention at this time; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby declares and expresses its intent to allocate and expend the sum of \$310,000 in revenue sharing funds as the City's match for the Southeast Economic Development

Corporation - UDAG grant application for construction of a hotel in Southeast San Diego, pending notice and hearing requirements necessary in connection with revenue sharing funds.

BE IT FURTHER RESOLVED, that the City Manager and City Clerk be, and they are hereby directed, to cause the necessary and appropriate notice to be effected for the above purposes.
